**ORDER**

Hon'ble Mr. Justice J. B. Koshy, Chairperson, Kerala State Human Rights Commission, as per the letter read above addressed to the Hon'ble Chief Minister and the Hon'ble Minister (Fin, Law and Hsg), has informed that the services of the sole Court officer is not sufficient to meet the requirements of the Commission considering the fact that the Hon'ble Chairperson and the two Members are holding sittings at the Headquarters and at the District Headquarters and that it has become inevitable to create at least two additional posts of Court Officers in the Commission to manage the general affairs of the Commission, relating to the conduct of cases and in particular, to deal with the sittings conducted at the District headquarters, to assist the Registrar in classifying and distributing the cases filed and to look after the cases allotted to the Chairperson and the two Members. He therefore, requested for creating two additional posts of Court Officer in the Commission.

2. Rule 13 (2) of the Kerala State Human Rights Commission Rules, 1998, issued as 2<sup>nd</sup> paper above, provides that the number of employees of the Kerala State Human Rights Commission, their qualifications, method of

appointment and scale of pay shall be as specified in the Schedule I to the above rules and / or as may be decided by the State Government from time to time.

3. Government have examined the matter in detail and are pleased to accord sanction for the creation of two posts of Court Officer in the Kerala State Human Rights Commission by deputation from the Law Department. The Government Order read as 2nd above, will stand modified to that extent. Necessary amendments to the Rules will be issued separately.

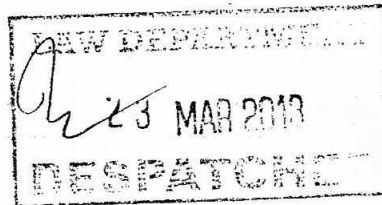
4. The expenditure in this regard will be met from the Grant-in-aid provided to the Commission.
