ORDER

The General Secretary, Kerala Law Secretariat Association, as per the representation read as 1st paper above, addressed to the Hon'ble Minister (Fin, Law and Hsg), has informed that there is no separate Office section in the Kerala State Human Rights Commission till date and that hundreds of petitions are being received daily in the Office. In order to facilitate the smooth functioning of the Commission, it has become inevitable to create the posts of one Office Superintendent, one Clerical Assistant and one Office Attendant in the Commission, to be filled up on deputation basis from the Law Department, for forming the new Office section in the Commission.

2. Rule 13 (2) of the Kerala State Human Rights Commission Rules, 1998, issued as 2nd paper above, provides that the number of employees of the Kerala State Human Rights Commission, their qualifications, method of appointment and scale of pay shall be as specified in the Schedule I to the above rules and / or as may be decided by the State Government from time to time.

3. Government have examined the matter in detail and are pleased to accord sanction for the creation of additional posts of one Office Superintendent, one Clerical Assistant and one Office Attendant, for forming a new Office Section in the Kerala State Human Rights Commission, on deputation basis from the Law Department. The Government Order read as 2nd above, will stand modified to that extent. Necessary amendments to the Rules will be issued separately.

4. The expenditure in this regard will be met from the Grant-in-aid provided to the Commission.


