NOTIFICATION

G. O. (P) No. 19/2006/Law. Dated, Thiruvananthapuram, 31st January, 2006.

S. R. O. No. 85/2006.—In exercise of the powers conferred by section 41 of the Protection of Human Rights Act, 1993 (Central Act 10 of 1994), the Government of Kerala hereby make the following rules further to amend the Kerala State Human Rights Commission Rules, 1998, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala State Human Rights Commission (Amendment) Rules, 2006.

(2) They shall come into force at once.

2. *Amendment of the rules.*—In Schedule I of the Kerala State Human Rights Commission Rules, 1998,—

(1) after Column No. (5), “Qualifications” the following column shall be inserted, namely:—

“Experience

(6);”

(2) the existing column number (6) shall be renumbered as column (7);

(3) after serial number 5, the following entries shall be inserted, namely:—

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Government vide G. O. (Rt.) No. 1019/05/Law dated 16-12-2005 have created one post of Public Relations Officer in the Kerala State Human Rights Commission in order to appraise the people at large about the activities of the Commission. Government have also decided to amend the Kerala State Human Rights Commission Rules, 1998 so as to include the said post in the schedule.

The Notification is intended to achieve the above object.
